### **CONCEPT NOTE**

#### **Background Information**

The Science Granting Councils Initiative in sub-Saharan Africa (SGCI-1) was launched in April 2015 with an initial 5-year funding (2015–2020) from the UK's Foreign, Commonwealth and Development Office (FCDO), IDRC and South Africa's National Research Foundation (NRF) to strengthen the capacities of Councils in African countries in order to support research and evidence-based policies that can contribute to economic and social development.

Specifically, SGCI-1 focused on strengthening the ability of the Councils to: (i) Manage research; (ii) Design and monitor research programs, and to formulate and implement policies based on the use of STI indicators; iii) Support knowledge exchange with the private sector, and; iv) Establish partnerships among Councils with other Science system actors.

A second 5-year phase of the SGCI (SGCI-2; 2018-2023) was launched in July 2018 with support from the Swedish International Development Cooperation Agency (Sida) and IDRC to deepen ongoing work with the Councils in areas related to those covered under SGCI-1.

Under this phase, the project titled Strengthening the Capacity of Africa's Granting Councils in Research Management was funded with the overall goal of fortifying the capability of Science Granting Councils in explicit areas of research management, namely research excellence (particularly the knowledge and use of tools such as Research Quality Plus framework), research ethics, emerging scientific practices (especially open data, open access and citizen science) and development of online grant management systems (including databases of peer reviewers).













The five specific objectives of this project are to:

- 1) Provide training and technical support to the SGCs on research excellence and emerging scientific practices e.g. research quality benchmarking frameworks, benchmarking and strengthening of financial governance of grant funding and other emerging areas.
- 2) Provide support for the design, development and deployment of digitised grant management systems including designing and implementing databases of national and regional peer reviewers.
- 3) Facilitate the design and writing of national/ regional studies intended at intensifying knowledge and implementation of research ethics in the African context in partnership with the SGCs and relevant experts.
- 4) Facilitate and oversee development of various research frameworks, manuals and procedures.
- 5) Facilitate opportunities and platforms for peer-to-peer learning among SGCs through staff exchanges and learning visits. The focus of the staff exchange and learning visits would be knowledge exchange and practice of research excellence and emerging scientific practices e.g. open data, open access and citizen science

#### **Participating Countries**

The Research Management Project is being implemented in 17 sub–Saharan African countries – Kenya, Uganda, Tanzania, Zambia, Zimbabwe, Ghana, Cote d'Ivoire, Senegal, Namibia, Botswana, Burkina Faso, Mozambique, Sierra Leone, Nigeria, Ethiopia, Malawi and Rwanda.

#### **About the Research Excellence & Ethics Workshop**

Building upon the project's significant impact and to further strengthen and consolidate its achievements, a Training of Trainers workshop is being organised under the no-cost extension of the SGCI Research Management Project. This 5-day capacity building workshop is being convened in Livingstone, Zambia, and will focus on various topics related to Research Excellence, Research Ethics, and Good Financial Grant Practices. The primary objective is to equip participants with essential skills and knowledge in these areas to improve their outcomes and more generally, to strengthen Africa's research ecosystem. An engagement session by the Africa Centre of Technology Studies (ACTS) is also featured on the workshop's programme, in line with the SGCI's overall effort of promoting cooperation, synergistic efforts and collocation among the collaborating technical agencies (CTAs) whenever feasible. Further information on each of the workshop themes are provided below:

#### Research Ethics:

In 2022, the Association of African Universities (AAU) commissioned a study under Phase 2 of the Science Granting Council Initiative (SGCI), aimed at informing the development and implementation of three (3) frameworks and guidelines for its participating members. A research ethics manual was developed as part of this activity. The training of the trainers' workshop sessions to hold under research ethics, builds on these previous efforts, and will provide an opportunity for the Councils to build the capacity to assess and practically develop the necessary tools and frameworks needed for the effective implementation of research ethics within their respective SGCs. Among others, this component will focus on key research ethics frameworks, implementing and safeguarding research ethics, identification of barriers and enablers to implementing a research ethics framework and monitoring and evaluating research ethics frameworks.

#### Research Excellence (RQ+ for Researchers)

Various impactful initiatives have been implemented under the Research Excellence component of the project. Key among them is the development of a Research Excellence Manual, the development and implementation of the Course in Assessing Research Excellence (CARE), and the rolling out of the course through capacity building workshops. Quite recently, in November 2022, Council teams were trained on CARE at an in-person workshop organised in Maputo, Mozambique. CARE was specifically designed for SGC members to introduce them to the RQ+ framework and prepare them to effectively implement its lessons and skills in their context to evaluate research linked to grants and funding.

However, the need to conduct similar workshops to empower researchers with the skills and knowledge to prepare research proposals and grant applications that adhere to the RQ+ guidelines for excellent research has become critical. Subsequently, an RQ+ for Researchers course was developed from the original CARE workshop, and the online web-based training reviewed and refined as necessary.

The component of Research Excellence holding under the ToT workshop in Zambia will focus on building the capacity of the council members to be skilled to facilitate the RQ+ for Researchers course. The workshop will equip participants to be able to: 1) Introduce researchers to the AAU LMS and sign in to the platform; 2) introduce the online course in a two-day in-person workshop format; 3) support the trainees to complete the course content; 4) convene trainees after about 6 weeks for a one-day feedback session and present their research proposals / grant applications created as part of the course. The Zambia workshop will also present participants with training materials to use in conjunction with the online course material. These will include the RQ+ for Researchers workshop presentation slides, observational assessment forms, and the Monitoring, Evaluation and Reporting of Learning (MERL) forms. The CARE Risk and Monitoring and Evaluation Framework for instance, is one of the key training materials.

**Admission Requirements:** The RQ+ for Researchers course ToT requires participants to have first completed the whole RQ+ for Researchers course and received the course certificate as proof. The ToT workshop is designed based on the assumption that all participants are familiar with the course content, hence, the focus of the ToT workshop will not be on the content, but on the facilitation of the workshop.

#### **Good Financial Grant Practices:**

The Good Financial Grant Practice (GFGP) Standard is a public international quality standard in the financial governance and management of grant funding, made up of four practice areas: Financial Management, Human Resources, Procurement, and Governance. This component of the project targeted facilitating access of the councils to the GFGP certification to improve grants management. So far, the councils have been supported in various ways, including – conducting precertification assessment of councils for compliance with the GFGP and building their capacity to prepare to undertake the pre-Certification exercise. The exercise of conducting the Desk Based Review for compliance with gold tier standard, as set out in the GFGP requirements has also been completed, indicating gaps noted and making recommendations that need to be implemented to improve the SGCs operations as necessary. The Zambia ToT workshop will provide an overview of the Good Financial Grant Practice (GFGP) Standard, present highlights from the GFGP assessments and provide an important platform for a feedback session with the participating councils.

#### **Workshop Delivery Format**

The Research Excellence and Ethics Training of Trainers (ToT) Workshop will incorporate a diverse range of interactive and impactful formats, designed to optimize participants' learning experience. These formats include:

- Presentations by Workshop Facilitators: Esteemed facilitators will deliver informative and engaging presentations, sharing their expertise and insights on the topics of Research Excellence and Ethics.
- Brainstorming and In-depth Discussion Sessions: Participants will actively engage in brainstorming sessions and in-depth discussions, fostering a collaborative environment to explore complex ideas and address pertinent issues.
- Role-Play Scenarios: The workshop will feature role-play scenarios, allowing participants to practically apply various facilitation techniques and strategies. Through hands-on practice, participants can enhance their training skills.
- Reflective Sessions: Dedicated sessions will encourage participants to reflect on their current practices and compare them with the recommended approaches shared during the ToT workshop. This introspective exercise will enable participants to identify areas for improvement and implement best practices.





#### Post Workshop Initiatives - Sustaining Research Excellence and Ethical Practices

**Policy and Frameworks Improvement Support:** In line with continuing efforts to sustain research excellence and ethical practices after the workshop, support will be provided to the participating SGCs in their efforts to improve and update their policies and framework documents related to research excellence, research ethics, and aspects/practices related to the GFGP. This support will include reviewing existing policies, supporting councils without policies to draft one and offering recommendations for alignment with best practices and international standards.

**Training the Research Community:** As a Training of Trainers (ToT) workshop, all participating councils are expected to schedule and implement capacity building training for the research community in the participating countries. Participating councils in the Zambia workshop are expected to report tangible results from this activity, after a three-months duration.

**Follow-up Assessments:** Post the workshop, the organisers will conduct follow-up assessments to gauge the effectiveness of the workshop's training. This will include gathering feedback from the workshop participants and assessing their adoption of the RQ+ framework, research ethics guidelines, and GFGP standards in their respective SGCs.

**Collaborative Peer Learning Platforms:** The workshop organisers will continue to create the necessary platforms via various means, including online sessions and during SGCI project level meetings, to foster collaborative peer learning to facilitate knowledge exchange, best practice sharing, and ongoing discussions related to research management, ethics, and grant practices.

**Dissemination of Best Practices:** Lastly, the organising team will continue to engage the participating councils, tracking and showcasing the positive outcomes of the capacity-building efforts. Best practices recorded will be disseminated in various ways, including sharing success stories across the wider SGCI initiative.
